Dear Academicians,

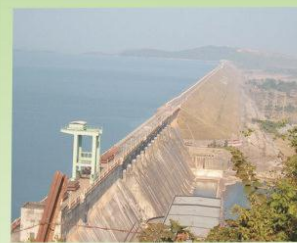
