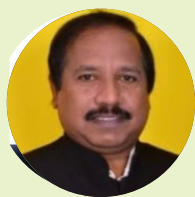

Abstract Submission Guidelines

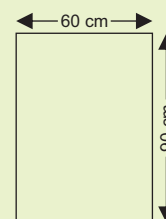
- Abstract must be in English, not more than **300 words (excluding Title, Author, and institutional affiliations)**.
- Authors: Mention the names in order of authorship, highest educational degree obtained, affiliated institution name.
- Abstract should be structured as **Background, Aims & Objectives, Methods, Result, Conclusion and 3-5 Keywords**.
- For Case Reports/Case Series - Background, Report proper, Conclusion and Keywords.
- Abstract should be in Times New Roman font of size 12 (**MS word format**).
- Title should be short, in upper case.
- Names of Authors should be underneath the title and affiliations should follow thereafter.
- Abstract should be original and should not have been presented earlier.
- **Do not include diagrams, illustrations, tables, references or graphics in the abstract.**

Guidelines for Paper Presentations

- Slides should be in bulleted or point by point format, not in paragraph.
- Time for presentation is **6 minutes + 2 minutes** for discussion.
- Presentation to be brought in pen drive compatible with MS Power point format.

Guidelines for Poster Presentations

- **Size of the poster should be 90 cm (H) x 60 cm (W).**
- Poster presentation should be in flex print format.
- All participants will get certificates for participation, according to the details filled in registration form.
- All entries are subject to scrutiny by the scientific committee before final approval.

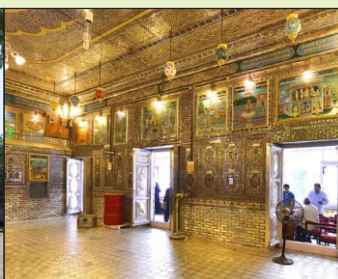

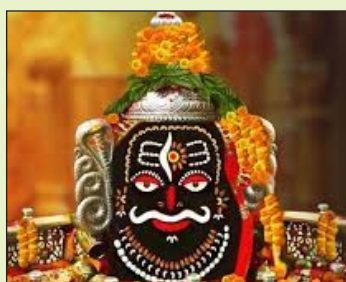
